been arbitrarily arrested and prosecuted under trumped-up charges  
Her unfair detention for the fact that she stood at the front  
line of peaceful protest, which was confronting abusive police officers.  
She has just made a heart-shaped symbol with her hands in  
front of riot police.

After that on 7 September 2020, Maryia was kidnapped by the  
Belarus authorities, and dragged into a van by masked men,  
she was taken to the border, and they obliged her to leave the  
country. She managed to escape but later she was arrested  
and they sentenced her to 4 years in prison.

This is an abuse of her fundamental rights of freedom,  
expression and association and I ask that you ensure her  
immediate release or if it is not possible at the moment  
to provide her healthcare and protection

Your Excellency, I am writing to express my deep concern regarding the detention of Neth Nahara, who has been convicted and imprisoned solely for peacefully exercising her fundamental human rights, including her right to freedom of expression. Freedom of expression is part of human dignity and a right enshrined in international law, including the ICCPR to which Angola is a party. The detention of individuals for expressing their opinions undermines the principles of justice and human rights, obscuring Angola's commitment to these values on a global stage.

I urge you to take immediate action to ensure the release of Nahara and to guarantee that her rights are fully respected and protected. Such an action would send a strong signal of Angola's dedication to upholding fundamental freedoms and fostering an environment where all citizens can express their views without fear of reprisal.

I trust in your leadership and commitment to justice and human rights, I hope you will act to address this thing.


I am writing to you regarding the case of Kyung Seok Park,
