

Good morning or good evening, It depends on which part of the world the receiver of this letter comes from, since I'm addressing anyone who walks on the same ground as me and looks up at the same sky. This is because I will deal with a fundamental topic that affects every single person. Soon it will be December 10, an ordinary day in a month where we only look forward to Christmas, but that isn't really the case. In fact, in 1948 on this date after a period of violence with World War II, the first Declaration of Human Rights was stipulated, establishing our inalienable rights regardless of race, color, sex, language or religion. For this reason December 10 was made official as World Human Rights Day, but after 75 years these are still not respected and this is why we need to talk about it and raise awareness of the topic. Too much discrimination is coming true, as happened

in 2021 in South Korea. The activist Kyung Seok who is part of the Solidarity Against Disability Discrimination movement made a peaceful protest to raise awareness and preserve the rights of people with disabilities. The authorities' wrong and aggressive solution was to suppress it with violence. The activist's determination has not been silenced, he want a world where no one is left behind. After reading this, I became worried. I have a close relative with a disability and to think that in another country he would not be fullfilled as a person or not be considered part of society templies me. Even if they have physical or mental limitations they have the same importance and opportunities as we do to carry out social, work, political and sport activities by taking advantage of what, despite the disability, are able of doing. They are so much more than their disabilities, which is only one characteristic that sets them apart. But unfortunately discrimination is not limited to these kind of people, but to anyone who is different from the idea of the standard man. We are talking about people who have a different culture or a different skin color. We as a women are also discriminated every day and we too are deprived of essential rights like the life just because we are women. In Italy, a free country, there are still increasing numbers of femicides. So it isn't only the fault of the state, but also of the culture of the individual. I appeal to anyone reading this letter: starting from the individual, if we all begining to appreciate the differences and welcome others with open arms, we would start limiting discrimination and no one would be left ~~behind~~ behind because we would understand that everyone has a dignity and a story to tell.

I want to talk about the second article of human rights that confirms that "everyone is entitled to all the rights and freedom outlined in this declaration, without distinction of any kind, such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status. Furthermore, no distinction shall be made based on the political, jurisdictional or international status of the country of territory to which a person belongs, whether it be independent, trust, non-self-governing or under any other limitation of sovereignty."

We agree as we think that everyone has the same rights regardless of their origins, religions, social status, race and sexuality, because we are all human beings. In these years too many people are still not respected

by others, even though there has been ⁱⁿ progress.

Everyone must be respected because respect is the basis of a civil and harmonious coexistence, every individual has an inherent dignity as a human being.

In these situations, it is very important to report and intervene if these are incidents of bullying or lack of respect, but above all fight prejudices and consequently learn new opinions and "put yourself in other's shoes".

Dear friend,

Do you think everyone has the right to be treated equally before the law?

We think so, in fact the article 7 of human rights explicitly says: "All are equal before the law and are entitled without any discrimination to equal protection of the law. All are entitled to equal protection against any discrimination in violation of this declaration and against any incitement to such discrimination."

People before the law can't and shouldn't be discriminated because of their race, sex, colour or anything else, those are not what define a person, so before the law they shouldn't matter or be some sort of proof against you or something that benefits you.

In the past, if a black-skinned person was against a white person, this one was going to win without any doubt.

During the year, these acts of discrimination have shifted to a more equal system, so that everyone could be equally protected before the law, for example, during a process where the person has every right to

request a lawyer as a defence. Unfortunately, this is not a reality for everyone: nowadays some people still get discriminated because of their religion, race and sex.

A clear evidence of this is the way women get treated in countries like: Iran, Palestine, Israel, Afghanistan and a few more. Women have basically no rights and the ones who govern are all men.

A famous story is Haruka's one, which most people know and tell to not act obvious just because these situations aren't happening to us. We find this so unfair, also because there are for sure other acts of injustice that are not told or known, but we really hope that everyone can actually be treated equally and protected against any discrimination.

All we can do know is learn how to behave, and by that we mean to not treat someone differently just because this people does not match our "normal person" type, but we have to accept and welcome everyone's differences.



any means and without regard to frontiers.
Article 19 of the Universal Declaration of
Human Rights says that everyone has the
right to freedom of opinion and expression.
This means that people are allowed to

without fear of punishment. It also means
that they can search, receive, and share
information from different sources.
This right is important because it helps
